Selecting your membership type

If you have a boat which regularly sails from Amble, you need to select either **Family** or **Single** membership. Families who want to include children as members should also select Family membership. If you don't have a boat sailing from Amble and don't want to include children in your membership, then **Associate** or **Joint Associate** membership might be suitable; there are, however, other distinctions between full (Family or Single) and associate types of membership, detailed below.

Family membership includes both adults—husband and wife or partners—and all their children (under 18 or 21 if in full-time education). Same-sex couples and lone parent families are included in this category. Both adults may vote in club proceedings.

Single membership is for a single person—whether or not in a marriage or partnership—who alone will have the rights of membership; children are not included in this type of membership. Any partner would have to be signed in as a guest and is restricted to six visits in any year. The member may vote in club proceedings.

Associate membership is for a single person – whether or not in a marriage or partnership—who alone will have the rights of membership. Any partner would have to be signed in as a guest and is restricted to six visits in any year. This type of member would not be able to vote in club proceedings, but may attend and speak.

Joint Associate membership is for a couple, however constituted, who will both have the rights of membership. Neither would be able to vote in club proceedings, but may attend and speak.

Cadet membership is for young people under 18 years of age (or 21 if in full time education) who will have the rights of membership but without the right to vote.

Overseas membership is for someone who is normally resident outside the UK, who would have the rights of membership when in the UK. There is no right to vote in club proceedings.

Make life easier - sign up for our Subscription Instalment Plan

We have a Standing Order scheme for paying your subscriptions. Ideally, we'd like to get all our members to use Standing Orders for their subs. It makes the administration of the club so much simpler (we're all volunteers) and, we hope, will make life a little easier for members.

There's no obligation to use the Plan, but we'd like to encourage you to do so.

And because it's not always easy to stump up the full subscription in one go, we are offering our Subscription Instalment Plan which means you can pay by quarterly Standing Order.

The Standing Order would run until cancelled. That means we don't have to send out reminders each year. If the subscription changes, we'd organise a new Standing Order for you: less form-filling for you. And, of course, Standing Orders can be cancelled at any time. Here's how it works:

Your subscription year will run from the date you are elected to membership. Your first Standing Order payment would be due immediately and then either quarterly or annually from that date.

Annual Standing Order

You may also choose to use an annual Standing Order for the full year's subscription. to start soon after you become a member; simply send the completed mandate to us and we'll take care of the rest. The annual amounts are shown in the table above in brackets.

Annual Standing Orders can also be used by Overseas and Cadet members (£10 a year and £5 a year respectively).

Cheque or Cash payments

Of course, it's entirely open to you to elect to pay by cash or cheque, in which case your annual subscription would be payable straight away and then annually on the anniversary of your election - we'd send you notice in good time.

Whichever method you choose, you're sure of a warm welcome from everyone at Coquet Yacht Club.

We aim to process your application for membership within ten days. Cheques and Standing Order mandates won't be acted on until you're elected to membership. Members of the committee - and members generally - are happy to deal with any questions you may have.
